### 2. Hazard Identification

Very hazardous in case of skin contact (irritant), of eye contact (irritant), of ingestion. Hazardous in case of inhalation. Slightly hazardous in case of skin contact (corrosive, permeator). Be particularly careful to clean folds, crevices, creases and groin. Cover the irritated skin with an emollient. If irritation persists, seek medical attention. Wash contaminated clothing before reusing.

**Serious Skin Contact:** Wash with a disinfectant soap and cover the contaminated skin with an anti-bacterial cream. Seek immediate medical attention.

**Inhalation:** Allow the victim to rest in a well ventilated area. Seek immediate medical attention.



**Serious Inhalation:** Evacuate the victim to a safe area as soon as possible. Loosen tight clothing such as a collar, tie, belt or waistband. If breathing is difficult, administer oxygen. **Ingestion:** Do not induce vomiting.
